Financial Report

From the President & Chief Executive

The past year has been one of notable growth, collaboration, and impact for Palliative Care NSW. Together with our members, funding partners, and supporters, we have strengthened our engagement with the sector through enhanced education opportunities, delivered new programs and resources and significantly expanded our reach into the community.

Key Achievements at a Glance:

- **Record Engagement:** Our 2024 Biennial State Conference in Tamworth was our largest to date and welcomed **300 delegates**, including **200 first-time attendees**, and featured **60+ presentations** showcasing innovation and excellence in care.
- **Education and Professional Development:** In addition to our State Conference, we delivered **15 professional education sessions** reaching over **600 current and aspiring healthcare professionals**. We hosted our largest-ever **Professional Education Day** with **232 attendees** across six locations including five first-time regional hubs and launched new online training resources.

- **Community Impact:** Through the End-of-Life and Palliative Care NGO Grants Program, we expanded **Community Conversations** statewide, launched **PalliLEARN** and reached **1,441 people** through these initiatives. Our **Palliative Care Guidance Manager** remains an important contact point for the community and the sector, taking over 550 calls, representing a 39% increase in calls this year.
- **Volunteer Services Support:** Celebrating **10 years** of volunteer support, we renewed funding, published research, updated key resources, delivered 9 education sessions and introduced the inaugural **NSW Palliative Care Volunteer of the Year** award.
- **Advocacy and Leadership:** We continued our advocacy on the **impacts of medicine shortages**, co-led the inaugural **Palliative Care and End-of-Life Policy Roundtable**, actively engaged with **Aged Care and NDIS reforms**, and ensured NSW voices were strongly represented in the national workforce survey.
- **Digital Growth:** Our website attracted **82,913 unique visitors**, social media engagement soared, and member communications achieved an impressive **72% open rate**.
- **Membership Growth:** Membership increased by **30%**, with strong uptake of individual professional and new organisational memberships.

Aligned with our State Conference theme, these achievements reflect our commitment to going 'Above and Beyond' in support of the services and individuals providing quality palliative care here in NSW, and in support of the community. This commitment requires the dedication of our small but mighty team, who we sincerely thank for all of their hard work.

An important extension of that team is our Management Committee who provide crucial governance and strategic direction. As the representative voice for our members across the state, we are pleased to have welcomed new committee members from rural and regional NSW this year. These positions are voluntary and organisations like ours cannot operate without the passionate individuals that choose to extend their support of the sector beyond their day-to-day professional roles. We sincerely thank you for your ongoing support and guidance.

As we look ahead, we remain focused on **our vision**: that Palliative Care is understood, valued and accessible to all, with equity at its heart, and delivering on **our purpose**: to lead, support and advocate for the development and provision of quality palliative care across NSW.






Professional Development & Member Engagement

Our Professional Education Day

To close out National Palliative Care Week, PCNSW hosted our annual Professional Education Day—bringing together **232 health professionals** for high-quality clinical content and peer networking. This year marked a milestone with **five new Regional Hubs across NSW**, complementing the main Sydney event. The day was professionally livestreamed from Sydney to Far West, Murrumbidgee, Northern NSW, and Mid North Coast LHDs, where attendees gathered in person to connect and engage.



The regional hubs were made possible through funding from the NSW Ministry of Health and the support of regional LHDs & PHNs.

Telephone Prompt Sheet & Communication Guide

To help address non-beneficial transfers of residents to hospital from residential aged care, PCNSW and PACN teamed up to create the ACD/ACP Telephone Prompt Sheet and Communication Guide. After months of collaboration, we developed a three-step decision tool for clinicians and a guide to help aged care staff communicate a resident's deteriorating condition with their enduring guardian/person responsible. 


Communication Skills in Palliative Care

Professional Networks

We are proud to offer two professional networks as a member benefit. Both professional networks continue to drive education, peer-to-peer networking and collaboration within the sector.

Volunteer Services Support Program



This year we celebrated 10 years of supporting palliative care volunteering in NSW through our Volunteer Services Support Program (VSSP), a professional and widely praised support program for palliative care volunteers across NSW. Highlights from this year include:

- Our renewed funding for 2024-2027 brought with it a new name - the Volunteer Services Support Program - and an update to our logo.
- Our main volunteer training resource, ***Palliare: A Handbook for Palliative Care Volunteers in NSW*** underwent a major re-write.
- The **Volunteer Managers Conference** was held in Sydney on 19 & 20 September.
- Our inaugural **NSW Palliative Care Volunteer of the Year** was announced.
- Supporting volunteers, volunteer managers, and volunteer services with **regional meetups and educational forums**.
- Continued hosting of the **NSW Network of Managers of Palliative Care Volunteers** running meetings every quarter. Four new services joined our network, 2 in Sydney metro and 2 from regional areas.
- The **Volunteer Hub** website remains the go-to repository for palliative care volunteering information with our 'Find a volunteer service' page the most popular.
- And we published research undertaken by Kate Bowman and our Macquarie University intern James MacDonald - ***Tracking the post-COVID recovery of palliative care volunteer services in NSW***.

10 Year Highlights

- **Supported more than 90 volunteer services** across NSW to increase capacity, support new service development, and raise public awareness of palliative care volunteering.
- Established the **Statewide Framework for Palliative Care Volunteering** in 2017.
- Delivered **over 60 educational forums** for palliative care volunteers and managers.
- Hosted **5 Volunteer Conferences & 4 Volunteer Managers Conferences**, held in alternate years.
- Developed and published training resources for volunteers including **Palliare: A Handbook for Palliative Care Volunteers in NSW (3rd edition)** and **About Palliative Care**: 5 online video modules.
- Hosted and maintained our online **Volunteer Hub** with resources and the palliative care volunteering service directory.
- Developed and published **14 operational resources** for volunteer service delivery.
- Published over **1000 news posts** and sent out over **85 monthly newsletters**.
- Published **27 research reports** or papers including comprehensive snapshots of palliative care volunteering every 4 years.
- Hosted and supported the **NSW Network of Managers of Palliative Care Volunteers**.
- Presented at **13 national and international conferences** on palliative care volunteering in NSW.


Edition 3 of Palliare Launched

The third edition of *Palliare: A Handbook for Palliative Care Volunteers in NSW* was written by Fiona Sivyer, Kate Bowman, and Dr Peta McVey. Significant changes to the previous edition were made to better reflect the landscape in which volunteers are active. Featuring 11 chapters it includes new content about cultural sensitivity and diversity, VAD, volunteering in aged care settings, and refreshed content on communication, spirituality, grief, loss and bereavement, boundaries, and self-care.

The handbook offers foundational knowledge and practical guidance for people volunteering in palliative settings. A copy of the Palliare Handbook is often given to volunteers at the start of their induction training.

Fiona Sivyer spoke about the value of *Evaluating Your Service* to ensure they are having a positive effect on client's quality of life and for the ongoing improvement of service delivery.

The importance of movement, colour, and creativity were not forgotten with Creative Arts Therapist and Volunteer Manager Adrina

Saroglu leading sessions on *Fostering Connections Through the Arts*. And Holly Smith from the Healthy End of Life Project introduced the Help App, showcasing how it can enhance communication by coordinating the practical and emotional support that a family needs as they come to terms with a loved one reaching palliative care or end-of-life.




Research




2025 NSW Palliative Care Volunteer of the Year Award

Four finalists were selected with the winner announced at an event during **National Volunteer Week**.





Winners of the NSW Palliative Care Volunteer of the Year Award will be nominated for the national awards hosted by Palliative Care Australia.



Community Support & Engagement

Our engagement with the community has significantly increased in 2024 and 2025. This is largely due to being one of six successful recipients of the End-of-Life and Palliative Care NGO Grants Program. This program which runs over four years aims to increase community capacity to engage with death and dying.

We now have a full-time Community Engagement and Programs Coordinator, Anthony Bui, and have been able to expand our **Community Conversations** program across NSW, as well as our online education program, **PalliLEARN**. A new partnership with the Healthy North Coast PHN further expanded that reach.


Our **CALD Community Connections Project** extended our reach to five multicultural groups in Western Sydney. While Dying to Know Day provided an opportunity to support LHDs, PHNs and community groups at their events.

Our **Palliative Care Guidance Manager** remains an important contact point for the community and the sector, with a 39% increase in calls this year. Our **Palliative Care Service Directory** is a key tool for those seeking specialist palliative care, along with our updated resources and tools.


Supporting the Community Broadcasting Association of Australia (CBAA) End of Life and Palliative Care 'Your Story, Your Decision' project.

This project (also an NGO grant recipient) aims to utilise the large network of community radio stations around NSW to provide relatable information about end of life and palliative care to a large and diverse community audience. We are delighted to be an ongoing supporter of this project and were featured in [Edition 1](#), while a member of our Volunteer Managers Network, Leanne Broadhead was featured in [Edition 3](#) discussing volunteers. This project is reaching a large audience with 96 NSW community broadcasters receiving the content and a high number of listeners engaging across NSW.



Engaging CALD Communities

We have also highlighted a number of **cultural days of significance** on our social media platforms, to recognise the importance these cultural events play in person-centred care, and to keep our members informed of traditions and celebrations they may observe their patients engaging in during that time.



Palliative Care Guidance Service

Our Palliative Care Guidance Manager Dr Peta McVey directs carers, family members and health professionals on how, when and where to access appropriate services that meet their needs. During this period there were **550+ phone calls** received. Of the calls received nearly **two-thirds (60%)** were **from carer/family members, followed by health professionals (33%)**.

The highest number of calls (52%) were related to needing an explanation about palliative care, how it operates, requests to access specialist services, discussion around symptom issues, practical issues and community home options (nursing and practical issues).

Of the callers, where location was identified, **58% were from a metro area** and **42% from a regional or rural area**.

Notes to the Financial Statements

PALLIATIVE CARE NSW INC.
For the year ended 30 June 2025

1. Summary of Significant Accounting Policies

The financial statements are special purpose financial statements prepared in order to satisfy the financial reporting requirements of the Associations Incorporation Act. The committee has determined that the association is not a reporting entity.

The financial statements have been prepared on an accruals basis and are based on historic costs and do not take into account changing money values or, except where stated specifically, current valuations of non-current assets.

The following significant accounting policies, which are consistent with the previous period unless stated otherwise, have been adopted in the preparation of these financial statements.

Property, Plant and Equipment (PPE)

Leasehold improvements and office equipment are carried at cost less, where applicable, any accumulated depreciation.

The depreciable amount of all PPE is depreciated over the useful lives of the assets to the association commencing from the time the asset is held ready for use.

Leasehold improvements are amortised over the shorter of either the unexpired period of the lease or the estimated useful lives of the improvements.

Employee Provisions

Provision is made for the association's liability for employee benefits arising from services rendered by employees to the end of the reporting period. Employee provisions have been measured at the amounts expected to be paid when the liability is settled.

Provisions

Provisions are recognised when the association has a legal or constructive obligation, as a result of past events, for which it is probable that an outflow of economic benefits will result and that outflow can be reliably measured. Provisions are measured at the best estimate of the amounts required to settle the obligation at the end of the reporting period.

Cash on Hand

Cash on hand includes cash on hand, deposits held at call with banks, and other short-term highly liquid investments with original maturities of three months or less.

Accounts Receivable and Other Debtors

Accounts receivable and other debtors include amounts due from members as well as amounts receivable from donors. Receivables expected to be collected within 12 months of the end of the reporting period are classified as current assets. All other receivables are classified as non-current assets.

Revenue and Other Income

These notes should be read in conjunction with the attached compilation report.

Revenue is measured at the fair value of the consideration received or receivable after taking into account any trade discounts and volume rebates allowed. For this purpose, deferred consideration is not discounted to present values when recognising revenue.

Interest revenue is recognised using the effective interest method, which for floating rate financial assets is the rate inherent in the instrument. Dividend revenue is recognised when the right to receive a dividend has been established.

Grant and donation income is recognised when the entity obtains control over the funds, which is generally at the time of receipt.

If conditions are attached to the grant that must be satisfied before the association is eligible to receive the contribution, recognition of the grant as revenue will be deferred until those conditions are satisfied.

All revenue is stated net of the amount of goods and services tax.

Goods and Services Tax (GST)

Revenues, expenses and assets are recognised net of the amount of GST, except where the amount of GST incurred is not recoverable from the Australian Taxation Office (ATO). Receivables and payables are stated inclusive of the amount of GST receivable or payable. The net amount of GST recoverable from, or payable to, the ATO is included with other receivables or payables in the assets and liabilities statement.

Accounts Payable and Other Payables

Accounts payable and other payables represent the liability outstanding at the end of the reporting period for goods and services received by the association during the reporting period that remain unpaid. The balance is recognised as a current liability with the amounts normally paid within 30 days of recognition of the liability.


